DOCUMENTS NEEDED FOR YOUR SNAP APPLICATION. When you apply for SNAP, your DHS worker will ask for documents to verify the responses on your application. Below is a list of items you may need: 1) Proof of identity and for immigrant applicants, verification of alien status (one of the below for each member of your household) Birth certificate

### [Documents Needed to Apply for SNAP Benefits](#)

You may be eligible to receive SNAP benefits within 7 days of your application date if you meet additional requirements. For example, if your household has less than \$100 in liquid resources and \$150 in monthly gross income, or if your household's combined monthly gross income and liquid resources are less than what you pay each month for rent or mortgage and utilities expenses.

Things you may show us that may make you eligible for more SNAP benefits: Housing costs \* Rent receipt, lease, or letter from your landlord or roommate; Mortgage statement, property tax, condo fees, home insurance bill or; Other document showing how much you need to pay Utility costs \* Bill for heat, air conditioning, electricity, gas or phone

### [Supplemental Nutrition Assistance Program - SNAP--Documents](#)

You are eligible for SNAP benefits if your countable resources do not exceed \$2,000 (\$3,000 if at least one household member is over 60 or disabled). Countable resources include your bank account and, in some cases, your vehicle. Your vehicle is only a countable resource if there is over \$1500 of equity in it. Your home and your furniture are not countable resources. Your net income cannot ...

### [SNAP Food Benefits | How to Get Help](#)

Food purchased with SNAP benefits is exempt from the state sales tax. However, sales tax is charged on the value of manufacturer's coupons that might be used in the transaction, and the sales tax must be paid in cash. Example: An EBT cardholder's groceries add up to \$27.50. She has manufacturer's coupons which total \$3.50, to reduce her grocery bill to \$24.00. \$24.00 is deducted from her EBT ...

Stores that accept SNAP are not allowed to set a minimum purchase amount to use the benefit. After you apply for SNAP, you will have to complete an eligibility interview and show the required documents. If you are eligible for SNAP, you will get it within 30 days. To maintain your benefit, you will have to recertify periodically.

Those benefits are automatically extended.
