Any changes to the particulars of the vehicle owner or title holder must be communicated to the appropriate registering authority within 21 days after such change. Use the notification of change of address or particulars of person or organisation (NCP) form. When you sell your vehicle, you must notify your registering authority on the Notification of change of ownership/Sale of motor vehicle (NCO) form. The new owner must register the car in their name.

Anytime there's a change to a vehicle or vessel's registered owner or lienholder, that change needs to be updated in DMV's records within 10 days and the California Certificate of Title needs to be transferred to the new owner. A change in ownership is usually due to: Sale, gift, or donation; Adding or deleting the name of an owner; Inheritance

A normal sale or a regular sale occurs when a vehicle owner sells the vehicle to another person. As a result, the vehicle's ownership and RC needs to be transferred to the new person. For this purpose, the transferor is required to submit Form 29 to the RTO.
